FUNDS OBJECTIVE

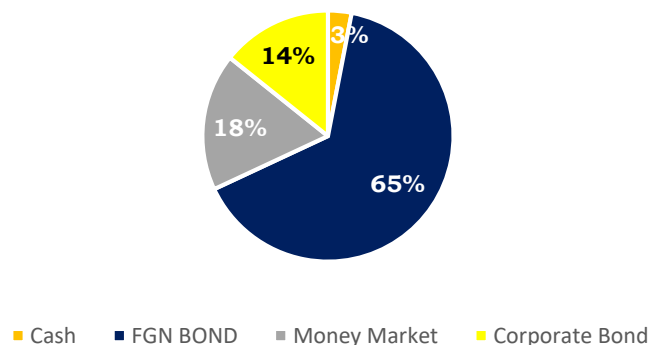

ASSET ALLOCATION

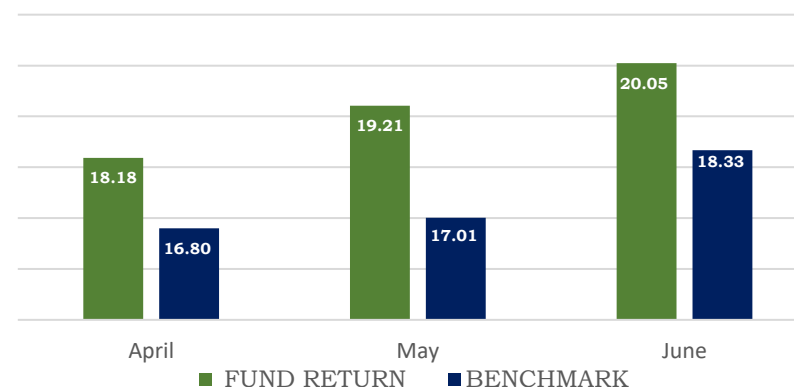

UTICA CUSTODIAN ASSURED FIXED INCOME FUND (UCAF)

The Fund's unit price grew by 0.77% (~~₦0.92~~) within the month, resulting in a YTD performance of 3.54%.

INSURANCE PROPOSITION

The life insurance provided by the fund shall cover death and permanent disability caused by accident. The insurance cover is up to 10 times the value of the unitholders' investment as at that of incidence. Any Unitholder who fully exists will not be eligible for cover.

INVESTMENT STRATEGY

The Fund employs a passive investment strategy, designed to track the performance of a well-diversified fixed-income portfolio while minimizing active management risks and costs. Portfolio adjustments are made only to rebalance allocations, accommodate index reconstitutions, or respond to changes in market conditions that affect the underlying securities.

DIVIDEND AND DISTRIBUTION

The Fund distributes income to its unitholders on a bi-annual basis, subject to the discretion of the Fund Manager and approval from the Fund's Trustees. Investors may choose to either reinvest their dividends or receive a cash payout to their bank accounts.
